PROPERTIES



Liquid. Does not mix with water. Floats on water. Combustible.

EMERGENCY



FIRST AID

Swallowed:	Give water (if conscious). Seek medical advice. Do NOT give milk or oil. Do NOT give alcohol.
Eye:	Wash with running water.
Skin:	Remove contaminated clothing. Wash with soap & water.
Inhaled:	Fresh air. Rest, keep warm. If breathing shallow, give oxygen. Medical attention.
Advice To Doctor:	Emesis generally unnecessary. Debride for subcutaneous injection. Evaluate for respiratory distress. Consider lavage with cuffed tube. NO adrenalin.
Fire Fighting:	Foam.
Spills and Disposal:	Eliminate ignition sources. Absorb with dry agent. Stop leak if safe to do so. This material and its container must be disposed of in a safe way. To clean the floor and all objects contaminated by this material, use water and detergent.

Storage and Transportation:	Store in cool, dry, protected area. Keep out of reach of children. Keep away from food, drink and animal feeding stuffs.
Fire/Explosion Hazard:	Vapours/gas heavier than air. Toxic smoke/fumes in a fire.
