Liquid. Gas. Does not mix with water. Floats on water. Extremely flammable.

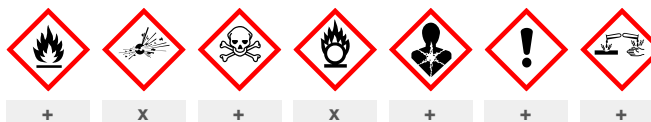
EMERGENCY



FIRST AID

Swallowed:	Do NOT give milk or oil. Do NOT give alcohol.
Eye:	Wash with running water (minimum 15 mins). Medical attention.
Skin:	Wash with soap & water. Apply cleansing cream.
Advice To Doctor:	Emesis generally unnecessary. Debride for subcutaneous injection. Evaluate for respiratory distress. Consider lavage with cuffed tube. NO adrenalin.
Fire Fighting:	Keep containers cool. Foam.
Spills and Disposal:	Eliminate ignition sources. Absorb with dry agent. Stop leak if safe to do so. This material and its container must be disposed of in a safe way.
