PRECAUTIONS FOR USE



Glasses:	Consider chemical goggles.
Gloves:	1.PE/EVAL/PE 2.VITON 3.TEFLON
Respirator:	Type AX Filter of sufficient capacity. (AS/NZS 1716 & 1715, EN 143:2000 & 149:2001, ANSI Z88 or national equivalent)
Storage and Transportation:	Store in cool, dry, protected area. Keep out of reach of children. Keep container in a well ventilated place. Keep away from food, drink and animal feeding stuffs. Keep away from heat. Keep away from sources of ignition. No smoking.

FIRST AID

Swallowed:	Do NOT give milk or oil. Do NOT give alcohol.

Advice To Doctor:	Evaluate for respiratory distress. Consider lavage with cuffed tube. NO adrenalin. Evaluate for respiratory distress. Consider lavage with cuffed tube. NO adrenalin. Decontaminate with ipecac or lavage. Ethanol therapy.
Fire Fighting:	Keep containers cool. Foam.
Spills and Disposal:	Eliminate ignition sources. Control vapour with water spray/ fog. Absorb with dry agent. Stop leak if safe to do so. This material and its container must be disposed of in a safe way. To clean the floor and all objects contaminated by this material, use water and detergent.
