<p>Swallowed:</p>	<p>Give water (if conscious). Seek medical advice. Do NOT give milk or oil. Do NOT give alcohol.</p>
<p>Eye:</p>	<p>Wash with running water.</p>
<p>Skin:</p>	<p>Remove contaminated clothing. Wash with soap & water.</p>
<p>Inhaled:</p>	<p>Fresh air. Rest, keep warm. If breathing shallow, give oxygen. Medical attention.</p>
<p>Advice To Doctor:</p>	<p>No antidote. Supportive care. Evaluate for respiratory distress. Consider lavage with cuffed tube. NO adrenalin.</p>
<p>Fire Fighting:</p>	<p>Keep containers cool. Foam.</p>
<p>Spills and Disposal:</p>	<p>Spilled liquid has low boiling temperature and evaporates quickly. Eliminate ignition sources. Consider evacuation. Prevent from entering drains. Contain spillage by any means. Control vapour with water spray/ fog. Absorb with dry agent. Stop leak if safe to do so. This material and its container must be disposed of in a safe way. To clean the floor and all objects contaminated by this material, use water and detergent.</p>
