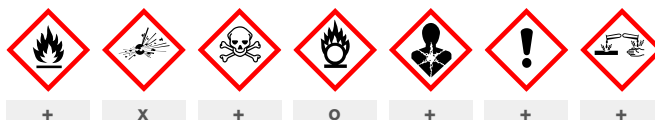
Eye:	Wash with running water (minimum 15 mins). Medical attention.
