PROPERTIES



Liquid. Gas. Does not mix with water. Floats on water. Extremely flammable.

EMERGENCY



FIRST AID

Swallowed:	Do NOT give milk or oil. Do NOT give alcohol.
Eye:	Wash with running water (minimum 15 mins). Medical attention.
Skin:	Wash with soap & water. Apply cleansing cream.
Advice To Doctor:	No antidote. Supportive care. Evaluate for respiratory distress. Consider lavage with cuffed tube. NO adrenalin.
Fire Fighting:	Keep containers cool. Foam.
Spills and Disposal:	Spilled liquid has low boiling temperature and evaporates quickly. Eliminate ignition sources. Control vapour with water spray/ fog. Absorb with dry agent. Stop leak if safe to do so. This material and its container must be disposed of in a safe way. To clean the floor and all objects contaminated by this material, use water and detergent.

Respirator:	Type AX Filter of sufficient capacity. (AS/NZS 1716 & 1715, EN 143:2000 & 149:2001, ANSI Z88 or national equivalent)
Storage and Transportation:	Store in cool, dry, protected area. Keep out of reach of children. Keep container in a well ventilated place. Keep away from food, drink and animal feeding stuffs. Keep away from heat. Keep away from sources of ignition. No smoking.
